She had advertised the ordinance before so the Supervisors could take action now. Supervisor Jeff Propps made a motion to adopt Ordinance 2012-12. Supervisor Harlen Anderson, Jr. seconded the motion. Any cost related to this ordinance must be handled by the property owner. Solicitor Myers presented a sample Fee Schedule for the Supervisors to review and discuss Byron Trout's fees. After the fees are determined a Resolution will need to be adopted.
