New Business:

Supervisor Ralph McGregor made a motion to have the Secretary advertise for bids for various stones, road oil, hot mix black top and fuels. Bids will be opened at next months' meeting on April 18

around 7:15 P.M. Supervisor Harlen Anderson, Jr. seconded the motion.

Supervisor Ralph McGregor made a motion to adopt Resolution 2022-02, using the Standard Allowance for the American Rescue Plan Act of 2021. Supervisor Harlen Anderson, Jr. seconded the motion.

Supervisor Dan McGregor reminded residents that Ag Security applications are due in the office by June 1st.

Supervisors discussed setting a fee for Transfer of Building Rights. This Ordinance was done September 19, 2016 but no fees were ever set. Solicitor Sharon Myers recommended passing all fees associated with this process to the applicant.
