The Washington Township Board of Supervisor's met at the Municipal Building on June 19, 2023.

All Supervisors were present.

Questions were asked about the high volume of accidents on RT 194 and the intersection of RT 74 and Wellsville Rd. He said he would look into these two concerns.

Old Business:

Solicitor, Sharon Myers, looked into Act 31 updates, restricting certain trucks on Township Rds.

She said signs can be posted only for trucks with trailers over 45' in length without conducting a traffic study. Documentation of why the restriction was placed on those roads is critical. For trucks under that length a study must be done to see if restrictions are warranted. No action taken at this time by the Supervisors.
